Data protection

The protection of your personal data is important to us. For this reason, we inform you with this privacy policy about the use of your personal data.

The association Surya Kiran – ein Sonnenstrahl für Kinder e.V., Arnikastr. 39/1, 73733 Esslingen, Management Board Mrs. Gaby Krüger, collects your data within the framework of the by-laws of the association in the currently valid version.

Data collection and processing is required for the implementation of the statutory requirements and is based on Article 6 paragraph 1b of the GDPR. These are your contact details (such as name, address, telephone number, e-mail account) and your account details (account holder, bank details, account number), as shown on page 1 of this application form.

A transfer of your data for advertising purposes does not take place. Disclosure to third parties takes place only within the scope of the necessary duties / duties provided by the articles of association, or due to legal requirements, e.g. the retention of donation receipts in the event of a review by the tax authorities.

Your data is erased as soon as it is no longer necessary for the purpose of its processing, e.g. when leaving our association. Legal retention periods are taken into account and fulfilled.

You have the right to object at any time to the use of your data for the purpose of providing information via a newsletter.

In addition, you are entitled to request information from the board of the association about you stored data as well as in the case of incorrectness of the data to request the correction or in case of improper data storage, the deletion of your data.

In case of violations of data protection law, you have the right of appeal to the competent supervisory authority. Responsible supervisory authority in data protection questions is the state data protection officer of the state of Baden-Württemberg.
